3. Case No * **ZA-2015-4126-CU, 2580 West Venice Blvd (SE corner Arlington)**
Development of a 4,386 sf. Shopping center with a 2,500-sf. 7-11 convenience store and two additional tenant spaces on a commercial corner lot. Requested entitlement: conditional use per LAMC Section 12.24.w27 to allow the 24-hour operating hours for a new 2,500 sf. convenience store in lieu of the limited commercial corner hours.

Proposal for UNNC to endorse a stakeholder-filed complaint to Planning requesting a Nuisance Abatement review (per LAMC 12.27.1) and revocation of all conditional use approvals for petroleum production at the 4th Ave site.
