UNNC Vision for a Washington Boulevard Specific Plan – reiterating UNNC’s previous approval of a community-endorsed proposed Specific Plan for Washington Boulevard (which has evolved into the City-proposed “CPIO”) and discussion regarding the relationship of this plan to future development projects—DISCUSSION AND ACTION
